
Central Okanagan Fire Relief Application



Disclaimer

The following document outlines the terms and conditions for applying to the Fire Relief Fund ("the Fund"). By submitting an application to the Fund, you acknowledge your understanding and agreement to comply with the terms stated herein.

Terms and Conditions:

Eligibility:

- 1.1 The Fund is open to individuals and families who have been directly impacted by fire-related incidents and are facing financial hardships as a result.
- 1.2 Applicants must provide verifiable proof of their direct connection to the fire incident, including but not limited to photographs, incident reports, or official statements.
- 1.3 The Fund is available to applicants of legal age in their respective jurisdiction. Applicants under the legal age must have a guardian submit the application on their behalf. Application Process:
- ${\bf 2.1\,Applications\,must\,be\,submitted\,through\,the\,official\,application\,form\,provided\,by\,the\,Fund's\,administrators.}$
- 2.2 All information provided in the application must be accurate and complete. Misrepresentation of information may result in disqualification.
- 2.3 The Fund reserves the right to request additional documentation to verify financial hardships, including proof of income, insurance claims, and other relevant financial records.
- 2.4 Applicants may be required to provide details about their specific financial hardships, such as rent, medical costs, and other related expenses.

Use of Fund

- 3.1 Approved applicants will receive financial assistance based on their demonstrated need and the availability of funds.
- 3.2 The Fund is intended to provide relief for verified financial hardships directly related to fire incidents. Funds may not be used for purposes other than those outlined in the application.
- ${\bf 3.3} \ Any \ misuse \ of the funds \ will \ result \ in \ immediate \ disqualification \ and \ may \ require \ repayment \ of \ the \ disbursed \ amount.$

Data Privacy

- 4.1 The information provided in the application will be used solely for the purpose of evaluating eligibility and distributing funds. Personal information will be treated in accordance with applicable privacy laws and regulations.
- 4.2 By submitting an application, applicants consent to the collection, processing, and storage of their personal information by the Fund's administrators.

Disqualification:

- 5.1 The Fund reserves the right to disqualify any applicant who fails to meet the eligibility criteria, provides false or misleading information, or otherwise violates the terms and conditions outlined in this document.
- 5.2 Disqualified applicants will not be eligible for further consideration or assistance from the Fund.

Amendments

- 6.1 The Fund administrators reserve the right to modify, amend, or update these terms and conditions as needed. Any changes will be communicated through the official channels of the Fund.
- By submitting an application to the Fire Relief Fund, you acknowledge that you have read, understood, and agreed to the above terms and conditions. If you do not agree with any of the terms outlined, you should refrain from submitting an application.
